



# Junior Flag Membership

*If you love to sail, be around boats and want an affordable entry into one of the world's greatest yacht clubs, here's your chance..*

**Eligibility:** To be a candidate for Junior Flag membership you must be at least ten (10) and not more than thirty-nine (39) years of age. You will be processed in the same manner as a Flag member. Candidates under the age of eighteen (18), must provide written consent of their parent or guardian. All applications must be accompanied by the transfer fee specified in the Dues and Fees chart. Junior Flag membership shall terminate on your fortieth (40th) birthday; during the time you will have the option to become a Flag member.

**Continuing Eligibility:** Junior Flag members are asked to contribute to the Club through participation in events each year as specified by the Board of Directors from time to time. The Junior Flag Board of Directors, in addition, has determined attendance at the Annual Junior Flag Meeting is mandatory for each Junior Flag member, unless excused by the Chair of the Junior Flags.

**Rights & Privileges:** Junior Flag members may not vote, hold elective office, or transfer their membership, nor does a Junior Flag membership entitle you to ownership in the assets of the Club or to distribution upon dissolution. As a Junior Flag member, you are entitled to all other privileges of the Club accorded Flag members; however, if you are under the age of twenty (20), you may not extend the privileges and courtesies of the Club to your family more than twice per calendar year.

**Dues & Fees:** The transfer fee for Junior Flag membership is \$50.00. Monthly dues for Junior Flag members ages ten (10) through fifteen (15) are one-eighth ( $\frac{1}{8}$ ) of Flag membership dues; dues for ages sixteen (16) through twenty (20) are one-quarter ( $\frac{1}{4}$ ) of Flag membership dues; dues for ages twenty (20) through twenty-nine (29) are one-half ( $\frac{1}{2}$ ) of Flag membership dues; and dues for ages thirty (30) through thirty-nine (39) are three-quarters ( $\frac{3}{4}$ ) of Flag membership dues.

Junior Flag members have no vested interest in the dues paid to the Club, however, in the event a Junior Flag member applies for, and is approved for, Flag membership by the Board of Directors, one-half ( $\frac{1}{2}$ ) of the dues paid as a Junior Flag member will be applied toward the then in effect transfer fee, as well as the purchase of a Certificate of Membership.

**Right to Transfer:** Junior Flag members may apply for transfer to Flag membership by making proper application through the Membership Committee. Such application must be made no later than three (3) months before the member's fortieth (40th) birthday. If approved by the Board of Directors for Flag membership, he or she may purchase a Certificate of Membership not more than two (2) months later if any such certificate is available. Failure to exercise this right of transfer or failure to be approved by the Board of Directors for Flag membership cancels the right and forfeits the accrued dues credits toward such transfer.

**Interim Junior Flag:** If a Certificate of Membership is not available to a transferring Junior Flag member having been approved for Flag membership by the Board of Directors, he or she may continue, as an Interim Junior Flag member until a Club-owned Certificate of Membership becomes available. Such a member shall continue Junior Flag membership rights, privileges and dues without further credits.
